

- PRICHARD, WILLIAM, *continued.*
to Cambridge June 22, 1775; "time out" Dec. 31, 1775; also, order for bounty coat or its equivalent in money dated Marblehead, Jan. 3, 1776; also, Private, Capt. Francis Felton's (Marblehead) co.; enlisted Jan. 8, 1776; service to Feb. 29, 1776, 1 mo. 24 days, in defence of seacoast.
- PRICHARD, WILLIAM. Private, brigantine "Massachusetts," commanded by Capt. Daniel Souther; engaged Aug. 19, 1776; discharged Dec. 21, 1776; service, 4 mos. 2 days; reported entitled to 1 share of prize money.
- PRICHARD, WILLIAM. Conductor; engaged July 30, 1778; discharged Sept. 23, 1780; service, 26 months; reported employed in (late) Deputy Quartermaster General's department at Boston.
- PRICKNER, JOSEPH, Boston. Descriptive list of men raised in Suffolk Co. for the term of 9 months from the time of their arrival at Fishkill; Col. Hatch's regt.; age, 21 yrs.; stature, 5 ft. 4 in.; complexion, dark; residence, Boston; arrived at Fishkill June 18, 1778. [See Joseph Barkner and Joseph Perikner.]
- PRIDE, JO., Presumpscot. Private, Capt. William Cobb's co., Col. Jonathan Mitchell's detachment; pay abstract for mileage, sworn to at North Yarmouth, Nov. 26, 1779; reported as having first drawn rations at Falmouth and as discharged at Falmouth; detachment raised in Cumberland Co. for service on Penobscot expedition.
- PRIDE, JOHN. Private, Capt. Samuel Knight's co.; enlisted July 9, 1775; service, 6 mos. 8 days; company stationed at Falmouth, Cumberland Co., for defence of seacoast.
- PRIDE, JOHN. Sergeant; list of men probably belonging to Capt. Jesse Partridge's co., Col. John Greaton's regt. [year not given].
- PRIDE, JOSEPH, Falmouth. Captain of a company raised in Falmouth; return dated Falmouth, Dec. 9, 1776, signed by Col. Jonathan Mitchell and Col. Timothy Pike, field officers in Cumberland Co., of officers appointed to command various companies drafted from the militia in accordance with an order of the General Court to serve under Col. Reuben Fogg; also, Captain, 3d co., Col. Peter Noyes's (1st Cumberland Co.) regt. of Mass. militia; list of officers chosen by the several companies in said regiment; ordered in Council Feb. 1, 1777, that said officers be commissioned; reported commissioned Feb. 1, 1777; also, Captain of a company in a detachment of Cumberland Co. militia commanded by Nathaniel Jordan, Esq.; joined Oct. 1, 1779; discharged Oct. 23, 1779; service at the Eastward; also, Captain, Col. Joseph Prime's (Cumberland Co.) regt. raised for defence of eastern Massachusetts; joined April 8, 1780; discharged Dec. 6, 1780; service, 7 mos. 28 days; enlistment, 8 months.
- PRIDE, JOSEPH. Private, Capt. Samuel Knight's co.; enlisted July 9, 1775; service, 6 mos., 1 week, 1 day; company stationed at Falmouth, Cumberland Co., for defence of seacoast.
- PRIDE, JOSEPH. Private, Capt. William Crocker's co., Col. Mitchel's regt.; service from Aug. 31, 1776, to date of discharge, Nov. 23, 1776, 2 mos. 23 days; company stationed at Falmouth, Cumberland Co., for defence of seacoast.
- PRIDE, JOSEPH. Private, Capt. William Cobb's co.; marched from home July 8, 1779; discharged Sept. 25, 1779; service, 2 mos. 17 days; company raised in Cumberland Co. for service on Penobscot expedition and served in Col. Jonathan Mitchell's detachment. Roll sworn to at Falmouth.
- PRIDE, JOSEPH, JR. Private, Capt. William Crocker's co.; service from March 1, 1776, to Aug. 31, 1776, 6 mos.; company stationed at Falmouth, Cumberland Co., for defence of seacoast.
