links thence north seventy nine degrees east one hundred & thirty five rool thence north eleven degrees thirty three rods four links & two thirds of one link to the first bounds the TO HAVE AND TO HOLD the aregrand and bargained premises , with all the privilege and appurtenances thereof , to the said William his heirs and assigns , to his thir use and behoof forever . And said do covenant with the William his heirs and assigns , that same lawful sized in of the premises ; that they are free of all incumbrances ; that have good right convey the same to the said William to hold as aforesaid .
