in consideration of the sum of two hundred and twenty five Dols - - - -

the receipt whereof I do hereby acknowledge—do hereby give, grant, bargain, sell and  
convey unto the said Sam<sup>d</sup> Pride - - - -

his - - - - heirs and assigns for ever  
A lot of land lying in Falmouth aforesaid bounded as follows  
viz. beginning at a stake standing on the west side of the Court-  
y road on a course North twenty two degrees west thirty six rods  
and twenty three links distant from the Northwest corner of  
Josiah Prides dwelling house in said Falmouth running  
South seventy two degrees west forty rods thence North  
twelve degrees west twenty rods thence North seventy two  
degrees East forty rods thence South twelve degrees East ad-  
joining the said road twenty rods to the first mention-  
ed corner, containing five acres - - - -

TO HAVE AND TO HOLD the aforegranted and bargained premises with all the privileges  
and appurtenances thereof, to the said Samuel Pride his - - - -

heirs and assigns, to his<sup>t</sup> their use and behoof for ever. And I do covenant with the  
said Samuel Pride his heirs and assigns, that I am lawfully seized in fee  
of the premises; that they are free of all incumbrances; that I have good right to sell and  
convey the same to the said Samuel Pride - - - - to hold as  
aforesaid. And that I - - - - will warrant and defend the  
same to the said Sam<sup>d</sup> Pride his - - - - heirs and assigns for ever,  
against the lawful claims and demands of all persons.
